Any derogatory information ascertained during the course of this investigation should be set forth in the details of the report.

Reference is made to the report of Special Agent Edwin R. Tully dated April 21, 1950, at New York entitled "Owen Lattimore - Espionage - R," Baltimore 100-1630, New York 100-94061, wherein information is set out that a confidential informant advised that during August 1949 Owen Lattimore received correspondence from one George Telberg, 3569 Broadway, New York City. The report indicated George Telberg to be the father of the employee and background information is set out. Nothing derogatory noted relative to the employee or her father.

Reference is made to Washington Field Office letter to the Bureau dated August 17, 1950, entitled "Conrad Ferdinand Taemmer, Commerce - LGE," WFO 121-14653, wherein a review of the June, 1941 issue of the American Sociological Review, official journal of the American Sociological Society is set out. This entire issue was entitled "Recent Social Trends in the Soviet Union" and reflected a series of articles by different authors devoted to praise of the Soviet Union. Ina Telberg was described as a Ph.D. (Ohio), a member of Ohio State University, on leave from Government service, who has lived in the Far East and done social work with the International Institute in the U. S. and is a specialist on foreign cultures. (121-23446)

Reference is made to Washington Field Office letter to the Bureau dated April 29, 1949, entitled "George Nickholoff Pirensky, was - Internal Security - C," WFO 100-19186, wherein information is set out that a highly confidential source furnished agents of this Bureau with a personal address book of George N. Pirensky. The following appeared on page 81 of this book: Ina Telberg, 234 East 19th Street - GR 3-5028. Pirensky has admitted former membership in the Communist Party from 1930 to 1939. (100-61314-124)

Reference is made to the report of Special Agent Frank R. Longo dated March 15, 1951, at New York entitled "Phan Duy Am, was., et al, Registration Act," New York 97-1184, wherein a mailing list of Vietnam American Friendship Committee is set out. The following appears on this list: Dr. Ina Telberg, United Nations, Lake Success, New York. The Vietnam American Friendship Committee supported the Vietnam-Government headed by Ho Chi Minh, a Communist. (97-2966-73 page 20)

In the conduct of investigations of this type you should refer to Bureau Bulletin 53-2, dated January 26, 1953. Your investigation should cover the employee's character, reputation, and associates as well as her loyalty. Office indices, credit and criminal, should also be checked concerning her relatives and the results incorporated in your report. The original and seven copies of your report are to be forwarded to the Bureau and the notation "Refer to Loyalty Section" should appear at the top of each original piece of correspondence. This case is to be assigned to mature and experienced agents thoroughly familiar with Loyalty and applicant-type investigations and care should be taken to avoid any adverse criticism of the Bureau in the handling of this important program. This case is to be assigned immediately and Buded must be met without fail.

The Washington Field Office in addition to necessary agency checks should review the files of the Immigration and Naturalization Service, State Department, and Central Intelligence Agency.

RESULTS OF INVESTIGATION

Mrs. ANNE D. SETTERFIELD, Third Avenue, Waterford, Conn., employed as a grade school teacher at Waterford, Conn., a reference, advised she first knew the employee in September, 1928 and both attended Wittenberg College at Springfield, Ohio, from that time until about 1931. She related that they were both active in the same college clubs and were close personal friends. She added that she later was closely associated with the employee from about 1936 to 1942 when the latter was doing Graduate work at the Ohio State University, Columbus, Ohio. She pointed out that she had little or no contact with the employee during the period 1942 to 1946 when the employee worked for the United States Government. She related she has been in contact with the employee about twice each year since 1946. They had corresponded with one another during this period.

Mrs. SETTERFIELD advised that the employee is a person of fine character, a reliable trustworthy person who enjoys an excellent professional and personal reputation. She added that the employee is completely loyal to the United States and she recommended her highly for work with the United States Government. Mrs. SETTERFIELD further related that she was in the same class with the employee's brother, VLADIMIR at Wittenberg College. She continued by stating the employee's brother is also a person of good character, enjoyed a similar reputation and was completely loyal to this country.

There is set forth below a United Nations loyalty case supervised in the Employees Security Section of the Bureau which is pending in your office and which is among the most delinquent such investigations being handled in the Bureau:

Ina Telberg.

This case is being brought to your attention to insure that it is being followed closely by both your investigative and supervisory personnel with a view toward completion at the earliest possible date. The Bureau is holding you personally responsible for the immediate completion of this case even though it may have been recently opened in your office by referral of leads from the Bureau or an auxiliary office.

The necessity for the earliest possible completion of this case cannot be overemphasized. As you know, much publicity is being given the Bureau's investigation of United States citizens employed by the international organizations coming under the purview of Executive Order 10422. Also, the date of the coming meeting of the United Nations General Assembly has been advanced to mid-August. In this regard, the Bureau has been confidentially advised that the status of the United Nations loyalty investigations will be discussed before the General Assembly by Henry Cabot Lodge, Jr., Chief of the United States Mission to the United Nations. It is, therefore, incumbent upon the Bureau to complete as many investigations as possible prior to that meeting, in order that the Bureau will have discharged, as far as is possible, its responsibilities under the provisions of Executive Order 10422.

The case listed in this letter does not necessarily represent the only delinquent case of this type in your office. You should immediately determine if there are any such cases in your office in which the deadline has past. If any are found, you must take the necessary action to see that they are completed without further delay. It is your personal responsibility to see that your office meets the deadline in all these cases.

Miss MARGARET JOHNSON, Dean of the school, advised that the employee attended the School of Applied Social Science during the above dates. She stated that the employee's date of birth is listed as November, 1908 in Tiazan, Russia. (Note discrepancy)

JOHNSON stated that the employee was in this country on a student passport which would expire upon her graduation. She declared that shortly after the employee came to this country her parents were forced to flee to China from Czarist Russia. The employee's concern for her parents' safety caused her to work under a constant strain during her stay at Western Reserve University. JOHNSON declared that the employee was ill on several occasions, which was probably due to the strain of worrying about her parents. JOHNSON added that, in spite of this worry and concern over her parents, the appointee did very well scholastically.

Dean JOHNSON stated that the employee was dependable, punctual, and cooperative, and a person of which everyone thought well.

JOHNSON also stated that nothing ever happened or was brought to her attention which led her to believe the employee would be disloyal to this country. She also stated that no one else at Western Reserve University would recall the employee.

FERGUSON added that she would not hesitate to recommend the employee for any responsible position.

Miscellaneous

Cleveland confidential informants, of known reliability, who are acquainted with Communist activities in the Cleveland area, advised that they do not know the employee.

Credit and Criminal

The files of the Cleveland Police Department and the Cuyahoga County Court of Common Pleas reflect no record for the employee.

No record was located in the Cleveland Retail Credit Men's Company which could be identified with the employee.

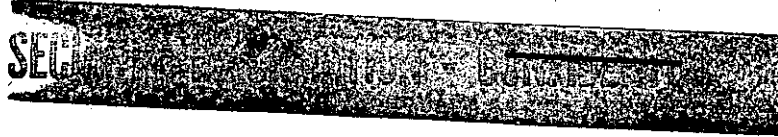

III. RESULTS OF INVESTIGATION:

Miss BONNIE WOODBURY, Transcript Clerk, Registrar's Office, Ohio State University, Columbus, Ohio, made available the scholastic records of the employee and the following information was noted:

Birth Data:

Born November 17, 1908, at Kazan, Russia. Her nearest relative in 1936 was listed as GEORGE GUSTAV TELBERG of Tsingtai, North China, her father.

Education:

Entered Ohio State University Graduate School on September 29, 1936, and received a Ph. D. in Sociology in June, 1942. According to the records, she had received her A. B. from Wittenberg College in 1931, and an M. A. from Western Reserve University in 1932. Her academic grades were excellent. No information reflecting adversely on her character, reputation, associations or loyalty appeared on the transcript records.

Mrs. GAILE QUICK, Clerk, Graduate School, Ohio State University, made available Graduate School records concerning the employee. These records gave little information concerning the employee beyond that found in the Transcript Office, except they reflected that the employee was employed in a teaching capacity while working for her Doctorate. Her supervising professors were named as Professor FREDERICK E. LUMLEY and Professor J. E. HAGERTY, both of the School of Sociology. Mrs. QUICK advised that both professors are deceased.

Employment:

Miss FRANCES J. JACOBS, Clerk, Business Office, Ohio State University, Columbus, Ohio, made available an index card from her files, which reflected that the employee was employed in the following positions at the Ohio State University School of Sociology:

1943	Leave of absence was extended until 1946

FLORENCE G. ROBBINS, Associate Professor, Department of Sociology, Hagerty Hall, Ohio State University, Columbus, Ohio, advised that she has known the employee since 1936 and had been a fellow student and fellow instructor of the employee. Miss ROBBINS stated that she considered the employee to be of excellent moral character and a loyal American citizen. Miss ROBBINS said that she knew of no associates of the employee who were of poor character or doubtful loyalty to this Government.

CARL A. NISSEN, Assistant Professor, Department of Sociology, Ohio State University, Columbus, Ohio, advised that he had known the employee well during the time she spent at Ohio State University. He advised that he and his wife were friendly with the employee at work and in social circles. Professor NISSEN said the employee was an excellent instructor, that her moral character was above reproach and her loyalty to the United States was unquestionable. Professor NISSEN stated that, to his knowledge, the employee associated with people of good repute and at no time consorted with any persons known to him to be disloyal. Professor NISSEN advised that he had never met any members of the employee's family but understood that her father is now a dealer in foreign books and lives in New York City. Professor NISSEN stated that he had never met the employee's former husband but that the employee had frequently mentioned him and had said he was an itinerant artist who never wanted to settle down and establish a home.

Neighborhoods:

Mrs. STELLA K. FRASCH, 2005 Waldeck Avenue, Columbus, Ohio, advised that she recalled the employee as a former roomer who had lived at her home from approximately 1937 to 1940. Mrs. FRASCH recalled the employee as a steady, dependable girl, of good morals and, to the best of her knowledge, loyal to the United States. Mrs. FRASCH stated that she never had any reason to question the character or loyalty of any of the employee's visitors or associates.

Mrs. TENNICE THOMPSON, Clerk, Olentangy Village, 2815 North High Street, Columbus, Ohio, could find no record of the employee as a resident of 3007 Neil Avenue, one of their apartment units. Mrs. THOMPSON explained that no records prior to 1945 of departed tenants have been kept.

Mrs. KELLY LAUGHEAD, Apartment 41C, 3007 Neil Avenue, stated that she recalled the employee as a former fellow tenant and said that to the best of her knowledge, the employee was of good character and a loyal citizen. Mrs. LAUGHEAD said that she could not recall any of the employee's friends or associates but had heard nothing derogatory about the employee in any way.

Mrs. JAMES HUBBELL, 2993 Neil Avenue, Columbus, Ohio, advised that she has resided in this neighborhood for sixteen years but could not recall the employee.

Credit:

Miss NELL HARDIN, Ohio Bureau of Credits, South Fourth Street, Columbus, Ohio, could find no record in her files concerning the employee.

Criminal:

MARY DODGE, Records Section, Columbus, Ohio, Police Department, could find no arrest or other record in their files identifiable with the employee.

Miscellaneous:

Reliable informants with knowledge of certain phases of Communist Party activity in and around Columbus, Ohio, advised that they do not know the employee and that they possess no information concerning her.

Miss HELEN DYER, Registrar at Wittenberg College, Springfield, Ohio, produced records which reflect that INA TELBERG was enrolled at Wittenberg College from September 11, 1928, through Summer School of 1930. She was, therefore, listed in the 1931 graduation and received her A. B. diploma on June 4, 1931. The records further reflect that Miss TELBERG majored in Economics and minored in Political Science and English.

These records contained no derogatory information relative to the employee and contained the following additional information concerning her:

She was born November 18, 1908, at Kazan, Russia. She attended N. China American School, Tunghsien, N. China. Her father was listed as GEORGE TELBERG, a Professor, and her home address was shown as 2 Chi-Hsia Rd., Tsingtas, Shantung, China. She was allowed credits from Harbin College of Law in Manchuria.

Miss DYER stated that she, herself, was a part time student and Secretary to the Dean of Students during the school year 1928-29. She stated that she recalled INA TELBERG as a member of the foreign students group and believed that she was a "White Russian." She said that, to her knowledge, Miss TELBERG's character, reputation, and associates were good when she was at Wittenberg College. She advised further that the employee, by action or word, had never given her cause to question her loyalty to the United States. Miss DYER pointed out that she has had no contact with INA TELBERG since June, 1929.

There is no record of INA TELBERG in the files of the Springfield, Ohio, Credit Bureau or the Springfield, Ohio, Police Department.



III. RESULTS OF INVESTIGATION

A review of the personnel records, Federal Records Center, General Services Administration, for INA TELBERG reflects that on January 23, 1946 she was transferred from the position of Field Representative, War Department, Strategic Service Unit, Washington, D. C., to the position of Interpreter-Translator, United States Forces, European Theater, Nurenberg, Germany.

On March 21, 1946, she made a three-day trip from Nurenberg, Germany, to Frankfurt and Wiesbaden for the purpose of visiting former colleagues in the China-Burma-India Theater. On April 13, 1946, she made a two-day trip to Frankfurt and Wiesbaden for the purpose of visiting friends.

On May 8, 1946, she was ordered to report to the Economic Division, OMGUS, Berlin, Germany, for a period of five days' temporary duty, to attend an economic conference at the request of General CLAY.

On June 8 and 9, 1946, she visited Munich, Germany, for the stated purpose of sight-seeing. On September 5, 1946, she left Nurenberg, Germany, to spend five days in Prague, Czechoslovakia. A notation in the records stated that she was in possession of proper visa and passport.

On November 10, 1946 she was transferred from the Office of United States Chief of Counsel, Nurenberg, Germany, to the Trade Agreement Conference, UNO, Frankfurt, Germany.

The records failed to reflect any further information concerning INA TELBERG's employment since that time.

The date of birth was shown as November 17, 1908, place not given.

III. RESULTS OF INVESTIGATION:

Dr. CECIL NORTH, 601 34th Avenue, Northeast, St. Petersburg, Florida, advised that he was formerly Professor of Sociology at Ohio State University. He recalled that the employee, INA TELBERG, studied for and received her doctorate at Ohio State University in about the late 1930's or early 1940's. During this period of time he was her chief advisor and came to know her quite intimately. He had visited at her home. Dr. NORTH advised that she appeared to be a very dependable person and of good character. Her behavior had always been proper. To his knowledge, she did not engage in excessive drinking of alcoholic beverages. Her associates were chiefly University students and members of the faculty, who were apparently of satisfactory reputation. He noted that she was well regarded in the Sociology Department.

Dr. NORTH advised that he considers the employee to be strongly devoted to the United States, a loyal citizen. In this regard he remembered that when World War II broke out she was so desirous of doing her part to assist that she went to Washington, D. C., immediately and there secured a position which subsequently took her out of the country for a time. It was his understanding that she had satisfactory service in this position. He recalled that after her return she secured employment with the United Nations.

Dr. NORTH stated that possibly two or three years ago while he was in New York he visited with the employee. He recalled taking the employee to dinner. She assisted him by telling him how to find his way around at the United Nations.

Dr. NORTH was not acquainted with the parents of INA TELBERG.

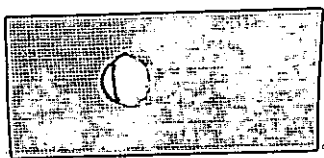

These cases are being brought to your attention to insure that they are being followed closely by both your investigative and supervisory personnel with a view toward completion at the earliest possible date. The Bureau is holding you personally responsible for the immediate completion of these cases even though they may have been recently opened in your office by referral of leads from the Bureau or an auxiliary office.

The necessity for the earliest possible completion of these cases cannot be overemphasized. As you know, much publicity is being given the Bureau's investigation of United States citizens employed by the international organizations coming under the purview of Executive Order 10422. Also, the date of the coming meeting of the United Nations General Assembly has been advanced to mid-August. In this regard, the Bureau has been confidentially advised that the status of the United Nations loyalty investigations will be discussed before the General Assembly by Henry Cabot Lodge, Jr., Chief of the United States Mission to the United Nations. It is, therefore, incumbent upon the Bureau to complete as many investigations as possible prior to that meeting, in order that the Bureau will have discharged, as far as is possible, its responsibilities under the provisions of Executive Order 10422.

In order that the transmittal to CSC of the results of investigations in these cases will not be delayed due to conditions over which the Bureau has no control, you are instructed to submit pending reports in each case in which the receipt of the results of an agency check is delaying submission of your report. The results when received should, of course, be submitted in report form, if pertinent.

The cases listed in this letter do not necessarily represent the only delinquent cases of this type in your office. You should immediately determine if there are such cases in your office in which the deadline has passed. If any are found, you must take the necessary action to see that they are completed without further delay. It is your personal responsibility to see that your office meets the deadline in all these cases.

It is, therefore, incumbent upon the Bureau to complete as many investigations as possible prior to that meeting, in order that the Bureau will have discharged, as far as is possible, its responsibilities under the provisions of Executive Order 10422.

The cases listed in this letter do not necessarily represent the only delinquent cases of this type in your office. You should immediately determine if there are such cases in your office in

which the deadline is past. If any are found, you must take the necessary action to see that they are completed without further delay. It is your personal responsibility to see that your office meets the deadline in all these cases.

Enclosed herewith are the original and seven copies of the report of SA EMMETT A. SCHMITT, at New York, dated 7/21/53.

New York File 65-61235 and Bufile 65-61504 entitled, "EUFROSINA DUOICHENKO-MARKOV, was; ESPIONAGE-R", reflects that a mail cover placed on the subject indicates that she had received correspondence from ~~GEORGE TELBERG~~, 3569 Broadway, NYC, the employee's father.

In view of the fact that this is a pending ~~FOIA(b)(7) (D)~~ investigation based on information furnished by [redacted] and the confidential nature of the investigation making it difficult to document, this investigation has not been included in instant report.

In referenced Bureau letter, the information set out that WFO had advised the Bureau that the employee had written an article entitled, "Heroes and Villains of Soviet Drama" and that her name and address was contained in the addressbook of ~~GEORGE N. DIRENSKY~~. *NY*

In order to avoid duplication, inasmuch as it appears that WFO was the origin of this information, no mention is being made of this information in the NY report.

NY The NYO indices reflect that a Miss EMILY SCRIBNER furnished information in 1952 on two different occasions which pertained to the employee. On the first occasion, Miss SCRIBNER appeared at the NYO and advised that she was in contact with a group of psychiatrists and other intellectuals, and gave a list of persons who attended week-end social intellectual gatherings, which she believes are a front for Communist activity. She stated these gatherings are held in a country home in Putnam County, but refused to reveal the exact location. She stated that she desires to have an agent accompany her to the location and cause a search to be made and uncover papers which may be of value.

Miss SCRIBNER advised that she attended several of these meetings and was suspicious of the nature and intent of the gatherings.

Miss SCRIBNER stated that she had a book of names, which she did not have with her and that she would furnish the Office with some of these names in the future.

On a later date, Miss EMILY SCRIBNER forwarded the Office a letter wherein she stated that she was forwarding a list of artists, musicians, and psychiatrists, who she believes are CP associates. Contained in this were the names ~~INA TELBERG~~, ~~MARGARET MEAD~~, STAPELFELDT, and ~~ELIZABETH HELLERSBERG~~, among others. NY

Because of the nature of this information, a lead was set out for a Miss EMILY SCRIBNER to be re-interviewed at her present address in Pawling, NY.

Miss SCRIBNER was re-interviewed and advised she has maintained a cottage in this area since 1934. Around 1950, she accepted a ride to Pawling, NY, from NYC, where she was employed at the time, from one KARSTON STAPELFELDT, who at that time had a place in the nearby area known as the Johnson Place. On the way they had an auto accident and inasmuch as she was all alone and had no one to care for her, STAPELFELDT suggested she go to the Johnson Place for a few days where she could receive rest and treatment for superficial injuries. She stayed there with the STAPELFELDT Family for approximately ten days during which time she met many friends and guests of the family. These people for the most part were school teachers and psychiatrists from NYC. During her stay there she noticed that STAPELFELDT had an unusually large number of films he was developing. She saw these films and the developed pictures of some of the films, all of which consisted of pornographic material, and a variety of snaps of nude women in lewd poses. On one of the strips of undeveloped film of lewd poses by nude women was attached the name of INA TELBERG. Miss SCRIBNER was of the opinion that this was a means of identifying the individual in the posed pictures. On another strip of film of like substance was

attached the name ELIZABETH HELLERSBERG. During her stay at the Johnson Place, STAPELFELDT suggested that upon her return to NYC, she visit a psychiatrist. Miss SCRIBNER stated she knew of no reason why STAPELFELDT should suggest that she see a psychiatrist. At any rate, he gave her the name of ELIZABETH HELLERSBERG to contact. Miss SCRIBNER said that she remembered that name as being one of the names on some of the nude pictures, so out of curiosity, when she returned to NYC she called ELIZABETH HELLERSBERG who had an office on Staten Island. She said she made up a phony story about having a single daughter who had become pregnant and that Dr. ELIZ. HELLERSBERG proceeded to discuss the possibility of having an abortion performed for the sum of \$50. Miss SCRIBNER said that no contract was entered into by them on this first visit and so out of curiosity again she made several phone calls to HELLERSBERG office for the purpose of getting names of other people who might help her with her "trouble" for a lesser fee. On several occasions, INA TELBERG answered the phone in HELLERSBERG'S office and acted in an official capacity. She said she also obtained HELLERSBERG'S home phone No. and upon calling there, the phone again was answered by a person identifying herself as INA TELBERG. Miss SCRIBNER summarized that HELLERSBERG and TELBERG shared the same office and lived together. Continuing, she said she did obtain some names of persons to contact from HELLERSBERG and these individuals all turned out to be persons whom she had met at the Johnson Place. She was then invited to the homes of some of these individuals for meetings. She attended one meeting and the discussions centered about sex and sex parties. According to Miss SCRIBNER, she never attended activities of all these individuals and so she along with some friends of hers whom she refused to identify started some private investigations on their own and according to her, they found out that HELLERSBERG acted as a contact woman for men and women who were unhappy in married life, and she would arrange "Trial Marriages" and Weekend Parties-some held at the Johnson Place - for the purpose of satisfying her "Patients" for a fee. She said she never saw INA TELBERG and only talked with her on the phone a couple of times. She said TELBERG want to Europe for the UN last year and she said her investigations showed TELBERG attended a lot of weekend parties as described above. She could furnish no additional information regarding TELBERG.

The interviewing agent advised that during the course of the interview of Miss EMILY SCRIBNER, which lasted for approximately two and one half hours, she rambled on about different topics and would state on different occasions she had records upstairs which she would check. She stated that she would go after these records, and then come down with a small slip of paper with a couple of numbers written on them and then spend time figuring what these numbers were.

A further check of the indices of the NYO by the writer indicated that Miss EMILY SCRIBNER has furnished numerous complaints to the NYO, all of which seem to revolve around the same group of individuals.

During the course of the interview with Mr. KARSTON STAPELFELDT, which comments regarding the employee are set forth in the report, he advised that he was acquainted with Miss EMILY SCRIBNER and considered her to be neurotic and who definitely needed psychiatric help. He advised that at one time Miss SCRIBNER had considered herself in love with him and when he rejected her, she tried to do everything possible to embarrass him.

Mr. STAPELFELDT was not advised that the information concerning his association with the employee was furnished by Miss SCRIBNER, but he immediately submitted it, and advised that Miss SCRIBNER had stolen an address book from him, which she returned at a later date and that she had made life miserable for the persons names whom she had copied from the book. She did this by calling them at different hours of the day and night, accusing them to be Communist sympathizers and sex perverts.

He advised further that Miss SCRIBNER is currently suing him as a result of an automobile accident wherein she was a passenger in his car. As a result of this suit, he has been unable to obtain Automobile Insurance.

Mr. STAPELFELDT, when questioned as to the alleged parties and pornographic literature that he was suppose to have at his country home, he stated that the only parties he could recall that were held at his place were parties held by his sixteen year old daughter and twenty year old son. As to the literature, he said he may at one time or another have had some snapshots of nudes that he was using in his work as a Commercial Artist, but that he could not recall ever having any literature that could be classified as pornographic.

In view of the fact that the information furnished by Miss SCRIBNER is of an unsubstantiated nature and the comments furnished regarding her by Mr. STAPELFELDT, the information furnished by her is not being included in instant report.

Among These friends was Dr. INA TELBERG, who was in an OSS planning group and divorced at the time. HEPPNER advised that TELBERG was interested in marrying JAMES WITHROW, who was a friend of JANE FOSTER.

TELBERG was subject of LEON case, Bufile 138-362, NY file 138-1058.

Miss KATHERINE LINDERMAN, U.S. Mission to the UN, (protect by T symbol), advised SA THOMAS J. MC SHANE on 3/22/57, that TELBERG had been employed at UN as a simultaneous interpreter at various periods from 11/10/46 to 6/30/49, and again from 7/1/49 to 10/10/54. LINDERMAN was unable to ascertain the reason for termination of employment by TELBERG. TELBERG not presently employed at UN.

3/18/57, that TELBERG was formerly employed at UN, but had to resign due to heart trouble and that she had not worked for several months prior to leaving this address in September, 1956.

Dr. A. P. MC COMES (female), 147 East 50th St., NYC, advised SA DICKERSON on 3/19/57, that TELBERG was a former patient of hers who had been seriously ill at one time and who suffered from mental strain and tensions of her position at the UN. MC COMES advised that TELBERG had stated that the Russian Delegation had accused her of deliberately misinterpreting their remarks during her employment and assignment as a simultaneous interpreter of the Russian language at the UN. MC COMES stated that while she had not attended TELBERG in about two years and did not know her present whereabouts or condition,

Mrs. M. L. KLINEMAN, owner of the building at 315 East 56th St., NYC, advised SA DICKERSON on 3/21/57, that TELBERG, a former tenant, had worked at the UN, but had to resign because of illness. KLINEMAN stated that TELBERG had spent a lot of time in hospitals prior to moving, but could offer no further information regarding her present condition or whereabouts.

CHARLES THOMPSON, Personnel Manager, Henry Hudson Hotel, 353 West 57th St., NYC, advised SA DICKERSON on 3/21/57, that TELBERG was residing in Room 1030 at the hotel and had been at the Henry Hudson since 9/27/56. THOMPSON stated hotel records reflected no information regarding any employment of TELBERG.

Efforts are continuing to determine reason for termination of subject's employment at UN and to determine present employment if any.

Bureau authority to interview TELBERG re her own activities while in OSS and her knowledge of JANE FOSTER ZLATOVSKI's associates and activities is requested.

She mentioned another instance in which a corporation desiring to hold a key man in its employ told him of derogatory information in FBI files which would prevent him from obtaining other employment.

Telberg's commitments did not enable N.Y. to thoroughly interview her about the above on 3/29/57. An appointment was made to continue the interview on 4/1/57.

On interview on 4/1/57 Telberg was pressed for factual information regarding leaks from the FBI. When pinned down, she admitted that she had no such facts. She said that she had formed an impression in this regard from information obtained at cocktail parties and social functions in the U.S. and abroad over a number of years. She could not recall specific persons who may have made statements to her nor could she recall specific statements. She stated that she could not recall the name of the prominent individual or the girl referred to above whose friendship was broken as a result of information from FBI files. She had the impression the girl resided in Germany and admitted that the information which she had heard could have come from some other agency. She could not recall the name of the person from whom she heard this story. With regard to the employee of a corporation who was held by the corporation as a result of information in FBI files, she stated she did not know the name of the corporation or the identity of the employee and could not recall where she had heard this story.

During the reinterview on 4/1/57 Telberg was emphatically advised that the statements she had previously made were irresponsible and untrue, and based on vague impressions rather than fact. She was emphatically cautioned about such statements.

RECOMMENDATION:

Inasmuch as it appears that Telberg has no specific information and may have been fabricating concerning alleged leaks from the FBI files and since she had denied any knowledge of subversive or espionage activities on the part of Jane Zlatovski, it is recommended that we not reinterview Telberg.

Miss EUGENIE BOUIANOVSKY, Economist, Department of Commerce, Office of International Trade, advised she has known the employee since about 1920 when they were both children. She advised on one occasion she lived at the home of the employee's parents in Tsingtao, China, for one month in 1924. She said her parents and the employee's parents were very friendly. She also stated that she has been a close friend of the employee and although she has only seen Miss TELBERG one or two times since the employee went to New York, they correspond regularly. She stated she knows nothing derogatory about her and considers her to be a straight-forward person who always conducts herself in a very good manner and she never discloses any confidential information in her possession. She knows of no reason to question the employee's loyalty, and knows of no organizations that Miss TELBERG belongs to.

Miss BOUIANOVSKY also declared that she is not familiar with any of the writings by the employee although she understands that Miss TELBERG is quite talented in this line. She stated that the employee's father is a person of good character, reputation, and loyalty to the United States and she knows nothing derogatory about him. She said that the employee's father wrote an article while in Russia by the title "Trial of the Czar." She said that he had been a professor at Harbin, China, in Manchuria, prior to 1924.

She concluded that the employee "is too intelligent to believe in any Red Propaganda."

SYNOPSIS:

Four persons were located who remember subject from the Nurnberg Trials, however no one knew subject well enough to be able to comment fully concerning her. Interviews and records checks failed to reveal any derogatory information concerning subject.

PREDICATION

Investigation was conducted at the request of Physical Security and Foreign Operations Staff, SY, memorandum dated July 9, 1953, in accordance with the provisions of EO 10422.

DEVELOPED INFORMANTS

Mr. Henry Einstein, Clerk of Court of Restitution Appeals at Nurnberg, who, in 1946 was a Research Analyst at the Nurnberg Trials, stated on August 11, 1953 that he remembered subject and had lunched with her one time, but that he did not know her well. He said that subject had a reputation of being very intelligent, a very fine interpreter, and that she was also "very eccentric".

Dr. Robert M. W. Kempner who is presently in a private legal firm in Frankfurt, and who formerly was General Taylor's Deputy Chief at Nurnberg, stated in a letter dated August 15, 1953 that he remembered subject "vaguely". He said that subject was known as a very good linguist and interpreter. He suggested that Colonel Leon Dostert, now in Washington, D. C., be contacted as he had headed subject's department in Nurnberg.

Mr. Thomas K. Hodges, Acting Chief of Program Planning Staff, Office of Public Affairs, HICOG, who in 1946 was special agent for CIC in the Language Section of International Military Tribunal at Nurnberg, said that he knew of subject by the name of KOSSAKOWSKI and not by TELBERG. He was unable to make any comments concerning subject except that subject was always with a group of expatriate White Russians, and that this group would never say anything about governments.

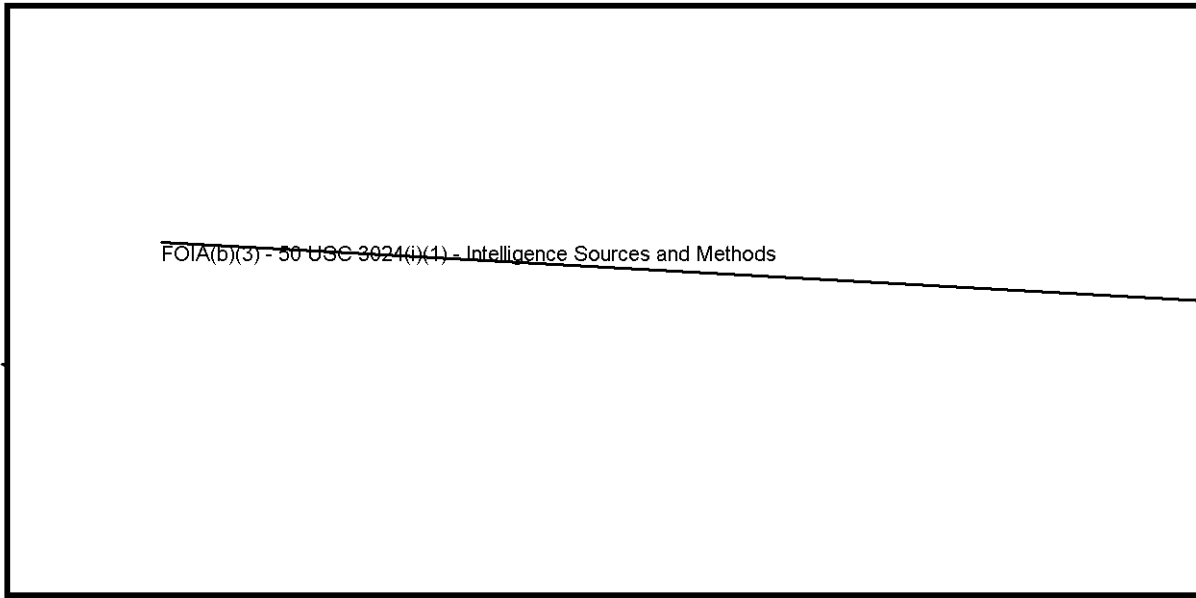

III RESULTS OF INVESTIGATION

AT MENLO PARK, CALIFORNIA

Dr. GREGORY BATESON, a reference who is presently employed at the United States Veterans Hospital, advised that he first met the employee when he became a member of the Office of Strategic Services (OSS) in 1943, and advised that he was associated with her from that time until the termination of World War II.

BATESON continued that he and the employee served together in Calcutta, India as OSS employees, remarking that both returned to the United States after the cessation of hostilities.

According to BATESON, he has not been in touch with the employee since the end of World War II, although he recalls having seen her in approximately 1948, at which time the employee was working for the United Nations in New York as a translator. Dr. BATESON stated that his ex-wife, MARGARET MEAD, was, to the best of his knowledge, associated with the employee during this period, inasmuch as she was collaborating with one JEFFREY GORER, a British anthropologist, on some Russian studies. According to BATESON, his former wife, MARGARET MEAD, met the employee while he, BATESON, was with OSS in New York and previous to his being sent by OSS to Calcutta, India.

BATESON continued that he does not believe that MARGARET MEAD and the employee have been closely associated since World War II, inasmuch as he understands that the employee has been in Paris on one or more occasions since 1945, possibly with the United Nations program.

GREGORY BATESON related that when he first met the employee he, BATESON, was engaged in the study of a Nazi motion picture from a psychological and anthropological aspect insofar as it pertained to propaganda. He continued that the employee was analyzing Japanese fiction for more or less the same purpose and in view of their somewhat mutual interests, she was transferred to his office.

~~CONFIDENTIAL~~ - SECURITY INFORMATION

BATESON continued that from his discussions with the employee, he believes that she was of Scandinavian origin, and stated she was probably born in Russia of Swedish parents and advised that she considers Russian her native tongue. BATESON remarked that it was his impression that the employee's parents were White Russians and were refugees from Russia several years ago, but added that he could not substantiate this information and therefore could not vouch for its authenticity.

BATESON volunteered that the employee was intensely interested in the secret societies of Japan, such as the Black Dragon Society. He remarked that because of such fascination it was quite possible that the employee would "flirt dangerously with such groups." BATESON related that he did not think the employee would go to the extent that she would collaborate knowingly with any enemy of the United States, and remarked that the employee is quick mentally even under trying circumstances, and to the best of his knowledge would not reveal any confidential information.

According to BATESON, his observations of the employee's beliefs while they were associated with the OSS left him with the impression that she was not at all "extreme left," but that she was liberal to the extent that she possessed a hardy dislike for imperialism in all its forms and always "favored the underdog." BATESON emphasized that the above statement was not to be construed to reflect that the employee was in any way Communistic or dialectic, and concluded that the final analysis of his opinion would be "loyal to the United States."

It is to be noted that GREGORY BATESON was investigated under the provisions of EXECUTIVE Order 9835 in 1950 in connection with his position as an Ethnologist - Appointee at the Veterans Administration Hospital, Palo Alto, California. In April, 1950, the chairman, Loyalty Review Board, U. S. Civil Service Commission, advised that DR. BATESON had been rated "eligible on loyalty."

RESULTS OF INVESTIGATION

Mrs. ELLA MADDOX, 7726 Capitol, Houston, Texas, advised she had known the employee for approximately five months in the early 1940's, at which time Mrs. MADDOX was managing a building located at an unknown address on Columbia Road, Northwest, Washington, D. C.

She states that her relationship with the employee was strictly on a landlord tenant basis, however, at one time the employee told her that she was doing "secret work and might some day disappear". She added that a friend of hers, whose name Mrs. MADDOX could not recall, would claim her belongings and forward them to her. Mrs. MADDOX added shortly thereafter the employee did disappear from the apartment and a short time later an unknown person came to claim the employee's belongings in the apartment. She states this is the last time she heard from the employee.

Mrs. MADDOX recalled that during the time employee resided in the above described building a person dressed in a military uniform would often be seen entering the employee's apartment without knocking and they would then engage in a lengthy use of typewriters. Mrs. MADDOX recalls the employee got large amounts of mail but does not recall seeing the return address on any of these letters.

Mrs. MADDOX added although the employee was a very mysterious person she had no reason to question either her loyalty, character or associates.

RESULTS OF INVESTIGATION

The files of the Immigration and Naturalization Service reflect that INA TELBERG KOSSAKOWSKI filed Petition for Naturalization #252156 on October 18, 1935, at the United States District Court, Southern District of New York. The file states that she was born at Kazan, Russia, November 17, 1908, and her nationality is shown as Scandanavian and her residence at the time of the petition is shown as 60 Jane Street, New York, New York.

The file also states that the employee claimed previous residence in the United States from September 3, 1928, to August 30, 1933, as a student during which time she married LUDWIG C. KOSSAKOWSKI. Her last foreign residence is shown as Fort Erie, Ontario, Canada. She immigrated to the United States from Niagara Falls, Ontario, Canada, and entered the United States at Niagara Falls, New York, via the Falls View Bridge under the name INA TELBERG. The file reflects the employee resided permanently in the United States from December 27, 1933.

The file also shows that at the time of her naturalization the employee changed her name to INA TELBERG CROSS. Her witnesses were KYRA MALKOVSKY, 241 East 17th Street, New York, New York, and SARAH SMITH, Manetta Lane, New York, New York.

The INS record also shows that the employee made application for re-entry into the United States and was issued Permit #963212 on April 12, 1934, which showed re-entry at San Francisco, California, on October 7, 1934, on the SS General Sherman.

The file reflects that the employee was issued Certificate of Naturalization #3955861 at the United States District Court, New York City, on March 23, 1936.

Professor LEON DOSTERT, Head of the School of Languages, Georgetown University, 1719 Massachusetts Avenue, N. W., advised he was the employee's supervisor on two occasions. He first served in that capacity in 1945 and 1946

at the Nuremberg Trials in Germany where he served as a colonel in the United States Army as Chief of the Language Services. The employee's position at that time was interpreter.

In 1946 and 1947 DOSTERT stated the employee was an interpreter with the United Nations in New York and served under him while he was employed as Chief of the Interpreter Section of the United Nations. He stated he has not been in close contact with the employee since he left the United Nations in 1947. DOSTERT advised, however, since that time he has seen the employee socially on several occasions.

DOSTERT further advised he considers the employee to be a brilliant person who is very capable and reliable. He has no reason to question her loyalty and to his knowledge she associated with members of the interpreting team who were all people of good reputation. He stated he is not acquainted with any of her social acquaintances. He further advised that the employee was a bit emotionally upset when she was under his supervision. He stated he believed this was caused by the job on which she was employed. DOSTERT also stated that the employee should be on a job where she can be creative and feel she is achieving something and not in a position where she is merely a "cog in a wheel" repeating the words of other people. He stated that this appeared to be bothering the employee and when she would go out socially and after having a few drinks she would become very talkative and loud though not intoxicated.

DOSTERT concluded that he knows nothing unfavorable concerning the employee and he would recommend her for a position of trust on the basis of his friendship with her during the 1945 - 1947 period. He stated he knows of no one else who could recall the employee other than those persons presently working with the United Nations in New York.

Dr. and Mrs. REDWIN BARRY, 1844 Columbia Road, N. W., Apartment 1A, advised that they have lived at this address for the past thirty-nine years but do not recall the employee and can advise of no one who would be able to furnish information concerning her residence at this address. Dr. BARRY stated that the ownership of this apartment house has changed hands several times since 1946 and the present owners are Walker and Dunlap Incorporated.

E. JAY BROWNETTE, Rental Department, Walker and Dunlap Incorporated, 1200 15th Street, N. W., advised that this company has owned the property at 1844 Columbia Road, N. W., for five or six months and they have no records prior to that time. He stated that the Ellsasser Realty Company were the former owners.

Mrs. VESTA PRESBEY, Secretary, Ellsasser Realty Company, 1844 Columbia Road, N. W., advised her company managed this building beginning in 1949 but she has no records that would reflect residence by any person prior to that time.

On a personal history statement executed by the employee in 1953 she claimed residence in care of AULL, 3516 Connecticut Avenue, N.W.

Pittman Studios presently occupies the building at 3516 Connecticut Avenue, N.W., and they are presently closed for alterations.

J. EDWARD COWHELL, 3518 Connecticut Avenue, N.W., advised he has been in business at this address for the past two years but does not recall the employee. He stated that there have been several different tenants at 3516 Connecticut Avenue in the past two years. He stated that the present owner of the property at 3516 Connecticut Avenue is Mrs. LOUISE MAZZA.

Mrs. LOUISE MAZZA, 3816 Cathedral Avenue, N.W., advised she does not maintain any rent records prior to two years ago and does not recall the employee or anyone by the name of AULL.

L. H. ROBERTS, 2819 Ordway Street, N.W., advised he owned a business at 3514 Connecticut Avenue in 1945 and 1946. He slightly recalls a woman by the name of AULL residing upstairs at 3514 Connecticut Avenue but he does not recall the employee. He stated he could not advise of anyone who would know the employee or who would know the whereabouts of Miss AULL.

Mrs. LILIE JANE RICHMOND and Mrs. ANNA MAE LOURENCE, 513 and 511 Second Street respectively, advised they do not recall the employee.

The files of the District of Columbia Credit Bureau contained no record for the employee.

The employee has no record in the files of the Metropolitan Police Department, Washington, D .C.

The files of the United States Park Police contained no record for the employee.

The files of the Passport Office, Department of State, reflect that the employee was issued Special Passport #406 on December 26, 1944, to visit Ceylon, India, Egypt, and Iraq on official business for the Office of Strategic Services. This passport was validated on August 20, 1945, at Calcutta, India, for travel in India for one year on official business for the Office of Strategic Services.

The files reflect the employee was issued Passport #237820 on June 24, 1948, to go to Geneva, Switzerland, for six months as an interpreter, Language Division, United Nations Secretariat.

The file also reflects she was issued Passport #512561 on October 1, 1951, to go to Paris for the Sixth Session of the United Nations General Assembly. Nothing derogatory is shown in the file and no further pertinent information is contained therein.

The files of Washington T-1, another government agency which conducts security and personnel type investigations, contain no additional pertinent information concerning the employee.

The files of Washington T-2, another government agency which conducts security and personnel type investigations, contained no additional information for the employee.

The available files of the United States Senate Committee on the Judiciary, the Sub-Committee to investigate the Administration of the Internal Security Act and other Internal Security Laws contained no record of the employee.

The employee has no record in the files of the House Committee on Un-American Activities.

Confidential Informants of known reliability who know some of the Communist Party activities in the Washington, D. C. area advised in July and August, 1953 that the employee is unknown to them.

The employee's name was checked against the records of the Identification Division of the Federal Bureau of Investigation and no criminal record was found.

ADMINISTRATIVE PAGE

CSC files reflect that CSC conducted an investigation on the employee in April, 1943 for the Office of Strategic Services when she was being considered as an Assistant Social Science Analyst at the Library of Congress. The file reflects that the investigation was favorable.

CSC files reflect a reference for the employee by the name of Dr. CORA DUBOIS. Miss DUBOIS advised on contact that she was leaving the city within the hour and would not return until the week of August 17, 1953. She stated she did not desire to be contacted prior to her return to Washington, D. C.

It is noted Miss DUBOIS is presently under investigation in this office under Executive Order 10422.

Confidential Informants in this case are [redacted] who furnished oral information to SA SEYMOR FRED PHILLIPS, [redacted] who orally furnished information to SA JOHN M. DEBETENCOURT, [redacted] who furnished oral information to SA THOMAS C. RIES.

The attached copy was sent to me from the Bar Association, in answer to a complaint regarding Newman Chaffee who was a neighbor of mine (an attorney). Chaffee claimed he could dissolve this marital tie which is on paper only.

I met a man, reported to be an attorney, at the Chaffee apartment on Thanksgiving Day, 1951 by the name of Steinberg. I appealed to him for nothing. I learned that Chaffee was inexperienced and associated with ~~him~~ in some way.

Steinberg denied making charges against me before the Board. This led me to believe he might have done "just that" when he writes such vicious letters.

I have not been to the Chaffee apartment since Thanksgiving 1951, as above mentioned.

I am not, neither have I ever been a member of any organization mentioned by Steinberg.

I am ready to meet any of my enemies, Chaffe and Steinberg included at any designated place of meeting.

"Perhaps it is well to state that last winter Emily Scribner was cited by the Board of Education of the City of New York where she had been employed for insubordination and disloyalty for consorting with known persons of communistic sympathies and attending certain lectures propagandizing subversive conduct. She came to me and I refused to represent her, she then went to Mr. David J. Steinberg's office and asked him to make a recommendation and he consulted another attorney who agreed to represent her at her hearing before the Board and fixed his fee at \$500.00 which she agreed to pay a week before the hearing took place. When she failed to do this and asked for an extension which was granted to raise the money she then changed her mind and demanded that she be given a guarantee that she would not be dismissed but would be re-instated inasmuch as she had been suspended without pay. When this so called guarantee failed to materialize she then went to other lawyers denouncing Mr. Steinberg and charging him with making the charges against her before the Board.

"Mr. Steinberg further informs me that altho. she had been charged nominally with merely insubordination of a superiors orders and instructions nevertheless and investigation disclosed that such insubordination was due to the fact that she had been ordered and warned and directed to cease and desist consorting and associating with disloyal persons known to be members of organizations of communistic teachings which were on the list of the U.S. Attorney General as Subversive organizations teaching and advocating by force and violence the overthrow of the U.S. Government. She had been repeatedly warned not to attend meetings of such organizations but she defied such warnings and continued to attend them.

While reviewing some notes taken in 1951, I find that I did see (a head and arm) of Dr? Ina Teleberg at the Greenwich address. A woman had called to discuss the rental of the apartment while Ina Teleberg was in Europe. I was some distance down the hallway and did not enter with this woman, who told me it was I.T. and the apartment was not for rent during her absence from the city.

If I said I never saw her, that meant that I did not call on her, or attend any of her gatherings, or whatever group meetings they have, here or elsewhere. I know nothing about the book that she was reported writing. She withdrew the title, "Dr." after some of the "prospective patients" learned that the UN did not have psychoanalysts and asked her where she was trained for this profession.

Quote: (Psychoanalysis Called a Step to Mortal Sin)

"From the moral point of view, one must say that the psychoanalytic method easily becomes a tool of corruption."

In January 1952, "Magazine Digest" printed an article entitled, 25,000 Marriage Meddlers on the loose. If some of these incompetent charlatans received more publicity it might help to obstruct the spread of psychoanalytic doctrines and techniques. (mind control)

I was already working on my research for "Prices Charged and the Procedures" used by psychologists in New York, where a person is so easily victimized, when I read this article.

I have assailed the Freud View for analysis and have been outspoken and blunt to people who have continued long and expensive treatments. "An escape in sex" does not solve personality problems,

I was then Secretary to Dr. Giles, the Director of Intercultural Education located at 119 West 57th Street. I do not know your area of interest or extent of travel so I am enclosing information at hand.

The Writer's Colony is some distance from New York and I do not have the exact address in the Middle West. I am not a member, have never visited there, but will send the names and addresses of the New Yorkers. Perhaps this is surplus information, but I promised to send "all and any" to your office as I learned about "contacts" in the professions.

It seems the usual line "capitalism is doomed", and other statements with which I am now aware, is the keynote of this group operating a "Charity Organization" for young writers. A book has just gone to a New York publisher from this group, which I am watching. The writer has denounced his Catholic church, family and friends after living at this colony. This colony does not want visitors. Some of the members were labeled as "phonies"...whatever that means to you. Some are not writers, but supposedly being "made into a pattern for writers.", regardless of their background.

MISS SCRIBNER WAS OF THE OPINION THAT THIS WAS A MEANS OF IDENTIFYING THE INDIVIDUAL IN THE POSED PICTURES. ON ANOTHER STRIP OF FILM OF LIKE SUBSTANCE WAS ATTACHED THE NAME OF ELIZABETH HELLERSBERG.

SCRIBNER STATED THAT STAPELFELDT SUGGESTED THAT SHE CONTACT A PSYCHIATRIST UPON HER RETURN TO NY AND GAVE HER THE NAME OF HELLERSBERG. SCRIBNER STATED THAT OUT OF CURIOSITY SHE CALLED HELLERSBERG WHO HAD AN OFFICE ON STATEN ISLAND, MAKING UP A PHONY STORY ABOUT HAVING A SINGLE DAUGHTER WHO HAD BECOME PREGNANT AND DR.
